**RESOLUTION AMENDING RESOLUTION 2022-03 AMENDING THE WARD PLAN FOR THE  
TOWN OF WARREN**

**WHEREAS**, Wisconsin Statutes sec. 5.15 requires municipalities to divide into wards; and

**WHEREAS**, the Town of Warren (the "Town") adopted its ward plan by resolution on September 20, 2021; and

**WHEREAS**, as a result of redistricting of legislative and congressional districts, a Town ward was split by legislative or congressional district lines; and

**WHEREAS**, the Town of Warren amended its ward plan to be in accordance with the redistricting of legislative and congressional districts by resolution on March 21, 2022 (Resolution 2022-03); and

**WHEREAS**, the legislative and congressional districts have changed since Resolution 2022-03 was adopted, and a Town ward is no longer split by legislative or congressional district lines; and

**WHEREAS**, pursuant to Wis. Stat. § 5.15(4)(c), wards may be numbered with a combination of whole numbers and letters; and

**THEREFORE, BE IT RESOLVED** that the Town of Warren hereby amends its ward boundary plan as described below:

**BE IT FURTHER RESOLVED** that the amended ward boundaries are outlined and identified on the attached map, which is incorporated and made a part hereof, and that the map is generated using WISE-LR software in order to incorporate the underlying census block numbers within each ward.

**BE IT FURTHER RESOLVED** that the polling place location for the wards shall be as follows:
